Planning and Development Services presented an overview of an application for a third dwelling located at NE 20-32-1-5, and provided information as introduced in the agenda package. including the location map, aerial photos and site photos.

Planning and Development Services provided specific information to the application as follows:

- Application is for an Existing Dwelling Unit (Third) (Manufactured).
- Zoning is Agricultural (A) District and the parcel size is 157.26 acres.
- Property is located within Division 7 and the rural neighborhood of Netook.
- Applicant / Landowner CIPPERLEY, Wayne George
- Previous approval was granted by Development Permit PLDP20120176 for a time limited term of 5 years. The permit will expire in August, 2017.
- Currently there are three dwellings on the property that exceeds the dwelling density of the Land Use Bylaw regulations.

- Property is directly south of Olds, within the Intermunicipal Development Plan Fringe Area.
- Surrounding land uses are Olds College, Town of Olds and the rest is prominently agricultural land.
- A condition of the 2012 Development Permit was to remove the manufactured home or the older dwelling within five (5) years. Intent was to have the dwelling density down to two (2) by the expiry date.

Intermunicipal Planning Commission had no comment or concerns.
