Policy Statement:

The Council of Mountain View County (the County) may officially name roads or sections of roads.

To provide a policy for administering applications requesting the naming of County roads.

Principles:

1. Mountain View County is committed to providing a clear understanding of the expectations and responsibilities of all parties involved in requesting consideration for the formal naming of County roads and ensuring that the same criteria for making decisions on the naming of roads is applied in a consistent and objective manner.

Procedure Title: Naming of County Roads
Procedure No.: 4002-01

1. Definitions

- 1.1 Chief Administrative Officer (CAO) - the individual appointed by Council to that position or their designate.
- 1.2 Road Name - the approved name given to a County Range Road or Township Road which shall not replace the rural address nomenclature but will complement it.

2. Guidelines

- 2.1 Requests for official naming of a road name shall be in writing and directed to the Chief Administrative Officer.
- 2.2 Names proposed for roadways shall meet the following criteria:
 - 2.2.1 be positive in nature;
 - 2.2.2 descriptive of an area;
 - 2.2.3 in common use;
 - 2.2.4 not used in an adjacent urban centre, and
 - 2.2.5 of regional significance or theme.
- 2.3 Use of personal names of living persons will not be considered.
- 2.4 An official road name will not replace the rural address nomenclature but will complement it.
- 2.5 All requests, in any case, will be subject to the approval of Council.
- 2.6 The CAO will include officially designated road names on editions of the County Map.
- 2.7 The Provincial Department of Infrastructure and Transportation is to be contacted regarding supply and installation of road signs to be placed adjacent to primary highways. All other road signs will be supplied and purchased by Mountain View County.
- 2.8 **Council may consult with the public prior to the naming or renaming of a road.**
