

BY-LAW NO. 9/97

Being a By-law of the County of Mountain View No. 17 in the Province of Alberta to provide for establishment of a general penalty for violation or breach of any County By-law.

WHEREAS it is deemed necessary that an up-to-date penalty by-law be established to cover violation or breach of any by-law of the County of Mountain View No. 17; in the Province of Alberta,

THEREFORE be it resolved that By-law No. 1/83 be cancelled and replaced with the following By-law

The Council of the County of Mountain View No. 17, in accordance with the provisions of Section 566 of the Municipal Government Act being Chapter M26 of the Revised Statutes of Alberta 1994 and Amendments thereto, enacts as follows:

PROCEDURE

Provincial Offences Procedure Act, chapter P. 21.5 of Revised Statutes of Alberta and Amendments thereto, for the purpose of procedure under the by-law of the County of Mountain View No. 17 regulating traffic in respect of which a penalty may be paid out of Court in Lieu of appearing in answer to the Summons, prescribe the amount of the penalty payable in respect of each offence.


