Policy Title: Century Family Farm Recognition

Policy Statement: Mountain View County recognizes the achievement of century family farms within its boundaries

and endeavours to honour such an achievement by the presentation of a plaque.

Purpose: To provide criteria to outline the eligibility of applicants and processes for administering the

Century Family Farm Recognition program.

Principles: In order to be eligible to participate in the Century Family Farm Recognition program:

1. The land must be continuously owned by the same family, having controlling interest, and/or be actively farmed or ranched for 100 years or more.

- 2. The applicant must provide evidence clearly demonstrating the kinship ties between the applicant and the founder of the farm or ranch.
- 3. The current homestead size should be at least 160 acres, i.e. a farm, not acreage. Special Council approval will be required for a family farm of less than 160 acres.
- 4. The applicant must provide the following information:
 - a) Date of homestead establishment
 - b) Land location
 - c) Copy of the land title

Eligible participants will receive a bronze plaque measuring 15" x 12" with the following inscription which will be presented to the family at a regular Council meeting.
