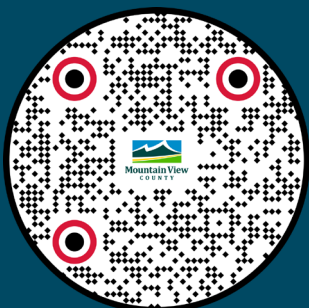

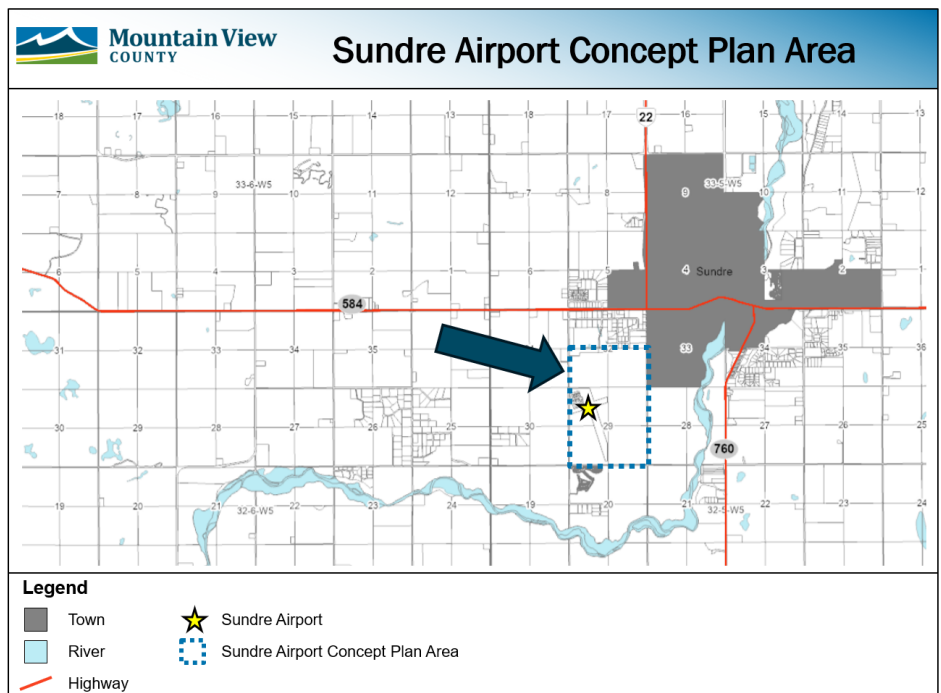

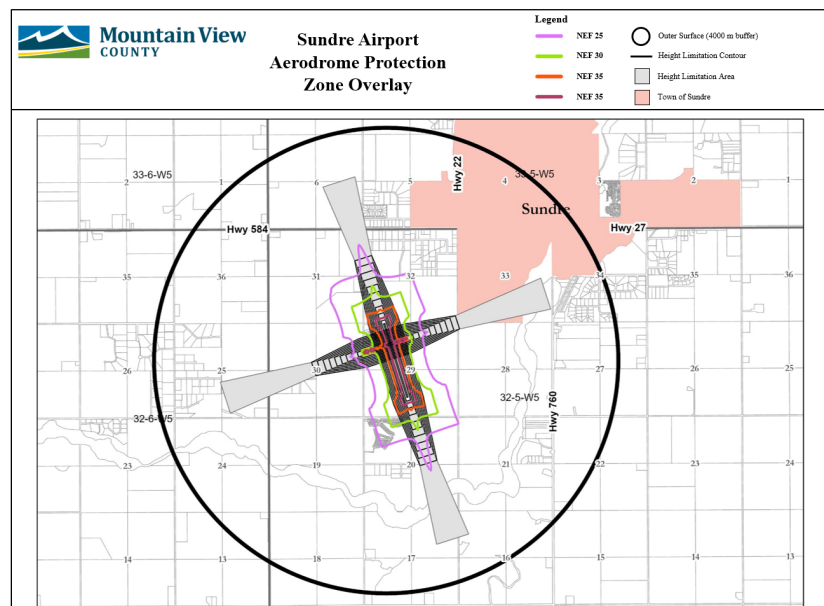
Mountain View County invites you to attend an Open House to learn and provide feedback regarding the proposed changes to the Aerodrome Regulations of the Land Use Bylaw.

WHY ARE THE REGULATIONS FOR AERODROMES BEING REVIEWED?

Mountain View County's Sundre Airport and Olds-Didsbury Airport are important facilities for surrounding communities.

To support responsible and up-to-date land use planning around these airports, consistent with Transport Canada guidelines, we are proposing amendments to the Land Use Bylaw. Although these proposed changes will go to Council independently of the Sundre Airport Concept Plan, their importance to airport areas makes it relevant to share this information with the draft Sundre Airport Concept Plan at this Open House.

Who should attend? – Owners of land within the *Height Limitations Area* or *Noise Exposure Area*; Owners of property close to one of the County airports; Aviation enthusiasts; or anyone interested in municipal planning of South McDougal Flats area
