- Administration demonstrated where the multi-lot and single parcels could be situated with the Agricultural Preservation Area taken into consideration.
- Steering Committee discussed that multi-lot areas could follow the paved roads such as Twp Rd 320 and east side of Hwy 760.
   Only go as far west as Rge Rd 61 as the hill could be a hazard if there is too much traffic.
- Steering Committee to consider the recreational and commercial designated areas – to expand or add new as suitable.
