To: Bergen Residents Re: Bergen Area Structure Plan Community Engagement

Mountain View Councy Council has initiated a review of the Bergen Area Structure Plan (ASP). The last Bergen ASP review was completed in 2015. Area Structure Plans are periodically reviewed and revised to account for changes in priorities and circumstances.

The Bergen ASP is a statutory document that outlines the community's vision for future development in the Bergen area. It helps ensure that developers and residents have a shared understanding of where and how different types of development should occur.

The stages of this ASP review process are outlined below:

STEP 04 🛛 🔨 🔪	The Steering Committee will finalize the draft ASP to be presented to the community at an Open House. Once the draft is finalised will be submitted to Council for formal approval. The community of Bergen will participate during the Public Hearing.
STEP 05	Once the ASP is approved by Council, it will be the guiding document for anyone who would like to develop or would like to subdivide within the Bergen ASP area.


A Community Engagement Session will take place on Wednesday June 4th, 2025, at 6:00 p.m. at the Bergen Community Hall.
