Guidelines:

- A financial statement and complete list of board members from the previous year must be included with the application.
- **Up to a maximum of \$1,500 may be approved for each registered cemetery organization in any given year.**
- Approved funding may be used for operating costs, special cemetery projects, and/or cemetery enhancements.
- The cemetery must be registered under the cemeteries act, or an organization acting on behalf of the cemetery board registered under the societies act.
- The property must be located within the boundary of Mountain View County.
- Goods or services serving an individual or private interest such as cemetery fees, funeral expenses, the purchase or replacement of grave markers, repairs to memorial markers, internment, etc. are not eligible for funding.
- Funding will not be granted for the purchase of land for the purpose of a burial ground or portion thereof.
- Volunteer hours will not be compensated for the purpose of operational or any expenses.
- Project-based or enhancement funding allocations must be completed within the same calendar year of approval.
- Approved funding may be used for fixed outdoor assets such as benches, signage, mapping, garbage and recycling collection, storage shed, etc.
- A financial report, including copies of receipts, must be received upon completion of the project. Applicants that have not submitted a financial report may not be considered for future funding until the prior reporting requirements have been met.
