Bergen Voices for Water

- Laurie Syer presented on behalf of the Delegation
- Background:
 - Bergen Voices for Water was formed following the first ASP Public Engagement Meeting at the Bergen Community Hall.
- Request to collaborate with the county to incorporate references to water within Statutory Plan documents. The Steering Committee accepted for information and made no further recommendations.

NEW BUSINESS

8.1

Future Land Use Concept - Recap

- Administration provided a Recap from previous meetings for the Future Land Use Concepts as provided in the meeting package.
- The recap resulted in a question regarding the location of the "Aggregate Advisory Area" previously in the Bergen ASP.

8.2

Future Land Use Concept - Exercise & Direction.

- Administration presented the Future Land Use Concept Exercise as directed by the committee to come up with criteria that is acceptable and measurable.
- Projected population increases were discussed based on the Future Land Used Concepts presented.
- Changes to the Residential Land Use Policies surrounding Parcel Density in the Agricultural Preservation Area requires an amendment to the MDP as Bergen ASP is not in an approved Growth Centre.
- The Steering Committee would need to justify to Council how the Bergen ASP is different from other areas within the County to vary the policies of the MDP.

Comments/Questions:

- How often do Reviews take place?
 - The MDP is typically reviewed every 5 years. A new council may review the document to some degree.
 - LUB is often reviewed with minor changes almost every year.
 - ASP's are on a rotating basis.
- Are there significant areas in the MDP review that may affected the ASP?
 - Residential policy changes in the MDP may impact the ASP.
- It will be a challenge for staff to review both the MDP and LUB and continue with the Bergen ASP review at the same time.
- It is anticipated that the MDP & LUB reviews will take about a year to complete.

- Administration recommends postponing the ASP review until the conclusion of the MDP & LUB reviews.
