Reeve Aalbers opened the Public Hearing regarding Bylaw #LU

28/22 and read the Bylaw.

The application for redesignation of the NE 17-29-3-5, was introduced by T. Connatty, Planning and Development Department, and the following information was introduced as provided in the agenda package such as the bylaw, location map, assessment map, site map, and aerial photos. The Planning and Development Department provided specific information to the application as follows:

- To create a separate parcel for the farmstead within the quarter
- Division 2

The Planning and Development Department recommended that Bylaw #LU 28/22 be given second reading.

The Planning and Development Department advised that all correspondence received was provided to Council.

Richard Gelowitz, owner, advised he wants to continue to live in the house on the property. The additional bit of land is to continue with the berry orchard. This application gives flexibility to a future purchaser.

Council questions resulted in the following information:

- As there is an ESA within the property, Agricultural Services has reviewed it and recommended that at the time of subdivision, add Condition 13 which is for environmental protection for that area, and that would be an agreement between the County and the landowner to ensure that it remains in a healthy state. This has been discussed with the landowners.
- The parcel does include the dwelling, an accessory building, and a garden. It also includes an area to the north which is a small track of orchard and can be utilized within. Agricultural uses are secondary to the residential use within a residential farmstead district. Including the berries allows for the opportunity as a secondary use for the landowners to continue to harvest berries in that location and reside on that property.
- Possible area for future development of an accessory building, which would comply with setback relaxations.

- The Adjacent landowner, Glenna Healey's property, is zoned Agriculture district A, and the parcel size is 65.8 acres. The landowner does not use the land for agricultural purposes and does not have a residence on it.
- There is no current requirement for a environmental assessment.
- Screening intent is to plant trees
- No parking is proposed with this application or within the agreement with the landowner.
- Speed limit is at 50 km per hour and any additional signage for safety would be put forward to operational services for consideration.
- For maintenance access there could be utilization of the approach on the north side of Bergen Road.
- Wildlife friendly fencing options could include dropping a wire for animals to cross or ensure animals can go around the fence or under. It will be an agricultural style fence, similar to riparian fencing.
- Using trees as screening and signage are additional ideas for deterrence of tresspassing.

- Access would be predominantly along the trail that's existing, it goes under the bridge from Davidson park into the subject property.
- There will be a continuous locked gate on north access, other than for maintenance.
- Passive recreation is a permitted use in the district and will require a development permit.

The Planning and Development Department was provided the opportunity for closing remarks and declined.
