PUBLIC HEARINGS Bylaw #LU 42/18 NE 16-29-4 W5M

Reeve Beattie opened the Public Hearing regarding Bylaw #LU 42/18 and read the Bylaw.

The application for redesignation of the NE 16-29-4 W5M, was introduced by D. Gonzalez, Planning and Development Department, and the following information was introduced as provided in the agenda package such as the bylaw, location map, assessment map, site map, and aerial photos. The Planning and Development Department provided specific information to the application as follows:

- To redesignate 5.11 acres from Agricultural District (A) to Residential Farmstead District (R-F).
- Division 2
- Rural Community: Water Valley/Winchell Lake

The Planning and Development Department recommended that Bylaw #LU 42/18 be given second reading.

The Planning and Development Department advised that all correspondence received was provided to Council.

Ken Taylor, applicant, stated that the landowners spouse passed away a year ago. Her son intends to take over the farm. They intend to remove the second dwelling and cabin. The owner intends to sell the proposed acreage. At this time they do not intend to do any further development on the balance of the quarter section. They are opposed to a caveat being registered on the lands regarding future development. The use of the adjacent well and pipeline has currently been suspended.

Reeve Beattie asked if there were any comments from the gallery.

Larry Gano, a landowner to the north, stated that he is concerned about future development because of the topography.

Reeve Beattie asked if there were any comments from the gallery. No one came forward.

Council questions resulted in the following information:

- The owners son intends to farm the balance of the quarter.
   He intends to build a new residence on other lands that he owns in the area
- The proposed size falls within the 2 to 10 acres for farmstead separation

The applicant was provided the opportunity for closing remarks and stated that the size of the proposed acreage is as small as possible in order to preserve farm land.
